

# City of Forest Acres TREE REMOVAL PERMIT APPLICATION

A tree removal permit must be obtained for the removal of trees within the City of Forest Acres unless specifically exempted by the Zoning Ordinance. If you are clearing trees in combination with dredging, grading or land filling, you must apply for a Land Disturbance Permit instead of a Tree Removal Permit.

**No application will be considered without a sketch indicating the location of all significant trees proposed to be removed and the reason stated for the removal of those trees.**

**No application will be considered if the tree removal service does not possess a current City of Forest Acres Business and Professional License.**

**The City of Forest Acres will not dispose of tree removal debris.**
