Mayor Frank Brunson called the meeting to order at 6:01 p.m.

- 2. Amendment to the Agenda

On a motion by Mr. Barnes seconded by Mr. Andrews, Council unanimously approved amending the agenda to accommodate three special proclamations.

- a. Presentation of the Order of the Palmetto to Lee Holloway On behalf of the Governor of South Carolina Henry McMaster, Mayor Brunson presented Lee Holloway with the esteemed Order of the Palmetto.
- Proclamation recognizing the service and retirement of Roy McBee
 Mayor Brunson recognized Roy McBee's service to the city and upcoming retirement.
- Proclamation recognizing the service and life of Linda Riddle
 Mayor Brunson spoke in honor of Linda Riddle and her death on August 14, 2021.

On a motion by Mr. Andrews seconded by Mr. Kibler, Council unanimously approved the minutes.

5. Mayor's Issues & City Projects

a. Responses to Community Forum Items: Vanwood pothole & roadway and median maintenance. Administrator Greenwood reported that he the pothole on Vanwood has been repaired.

The brush growing in the medians has been removed. A proposal related to median maintenance is being explored and Mr. Greenwood will have information for Council within a week or so.

6. Public Comment Related to Items on the Agenda:

7. New Business:

- a. MBLG presentation on regional gateway projects
 James Bennett with the Midlands Business Leadership group introduced himself and his colleague
 Katherine Swartz-Hilton. Mr. Bennett also represents First Citizens Bank as an Area Executive. The
 MBLG is a coalition of 50+ area executives that work on improvement projects including the
 Governmental Cooperation Initiative. The City of Columbia, Richland County, Lexington County, City of
 Cayce, City of West Columbia, and the Town of Springdale are currently participating in this initiative to
 improve and maintain the 8 gateways in the Midlands. The MBLG is inviting the Town of Lexington,
 Town of Irmo, and the City of Forest Acres to join the project. The cost per Governmental entity for
 ongoing maintenance is based on population. Forest Acres would commit for ten years of maintenance.
 Mr. Greenwood added that he will get the model of the Intergovernmental Agreement to Council for further
 consideration.
- b. Request by Lexington Medical Center related to their "Be Well" campaign and Citadel Park Mr. Greenwood said that Lexington Medical Center approached the city about partnering with them to replace our park water fountains to include bottle filling station. In return, the city would allow them to put small banners in our parks. Council expressed thanks to Lexington Medical Center but have no interest in commercial sponsorships at our parks.
- c. Discussion and approval of a contact with Recollect for their Waste Wizard program
 Following a brief discussion, on a motion by Mr. Andrews seconded by Mr. Barnes, Council unanimously authorized the contract to be executed by Mr. Greenwood.
- g. Hospitality Tax Committee recommendations related to requests for Htax Funding:
 - a. Gateway to the Army Centennial Project \$15,000 Presenting Sponsor Package at annual fund-raising event on November 10, 2021.
 Mr. Black said that after meeting with the committee it is their recommendation to authorize the request. On a motion by Mr. Black seconded by Mr. Andrews, Council unanimously approved the funds.
 - b. Gateway to the Army Centennial Project \$35,000 in additional funds for the completion of construction.
 - Mr. Black said that after meeting with the committee it is their recommendation to authorize

the request. Following a discussion on a motion by Mr. Black seconded by Mr. Andrews, Council unanimously approved the funds on the condition that monies will not be distributed until the project raises 50% of the \$600k required funds for the project.

- c. Town Theatre \$2,000 Picnic in the Park Concert Series October November Mr. Black said that after meeting with the committee it is their recommendation to authorize the request. On a motion by Mr. Black seconded by Mr. Andrews, Council unanimously approved the funds.

p. Discussion of a Vaccination Incentive Program for City Employees

Following a discussion Council agreed to offer one paid day off and a \$100 incentive for city employees to get the Covid vaccinations. The incentive will be retroactive for employees who have received the vaccinations and have their card. On a motion by Mr. Andrews seconded by Mr. Kibler, Council approved the program as amended.

On a motion by Mr. Andrews seconded by Mr. Barnes, Council unanimously authorized an alternative legal signature on the ordinances tonight in the physical absence of City Attorney Will Dillard due to illness.

Old Business:

a. 9. City Administrator Report:

a. ARPA Funds

Administrator Greenwood reported that these stimulus funds have been requested by the state. We have submitted our request for log-in information through a portal that the state has activated for requests of the funds.

b. PIO Position

Lynnsey Baker has joined city staff as our new Public Information Officer position. Her first day will be September 27, 2021.

c. Bridge replacement

The money that the state granted to us for our bridge replacement has been placed in the SC DOT budget. They wanted us to spend our money first and they would reimburse us. Mr. Greenwood expressed his opinion against that process. The project will continue.

d. FLP Park update

This project is moving forward. The money granted by the state is involved with this project as well.

e. Website update

The framework and online forms are completed. The timeline seems to be on target.

f. Public Works

Our staff in public works has been working diligently to work on all routes with being down by two trucks. Residents were not affected by delays due to the hard work.

10. Finance Director Report: Investment Policy report

Finance Director Andy Smith gave a report to Council regarding the city's investments and what type of funds are allowed. Mr. Smith added that he believes the state and local government pool we are invested in are suitable.

11. Police Chief's Report:

Chief Sealy reported that 11 FAPD employees were out with Covid during the month of August and a portion of September. Gaps were filled in by our other employees.

Chief Sealy recently attended a Servant Leadership program at Eastminster Church. He selected Sgt. Lori Tumlin for recognition of her community service in Forest Acres and outstanding work in FAPD.

The four new cameras that were installed at Trenholm park are active and running.

The Labor Day 5k race was successful with approximately 200 participants.

Chief Sealy officially announced his upcoming retirement. He will remain with the City until January 2, 2022.

12. Community Forum:

Resident Jim Testor expressed his concerns regarding fireworks in the city.
