MINUTES OF THE FOREST ACRES CITY COUNTIL December 13, 2022

Mayor Frank Brunson, Mayor Pro-tem Thomas Andrews, Council members John Barnes, and Haskell Kibler were present, along with Assistant City Administrator/Finance Director Andy Smith, Police Chief Don Robinson, and City Attorney Will Dillard. City Administrator and Council member David Black attended the meeting via Zoom.

Mayor Frank Brunson called the meeting to order at 6:00 p.m.

2. PUBLIC HEARING
