a. Responses to Community Forum Items:

Satchel Ford Road properties - Mr. Greenwood stated that we continue to monitor the properties on Satchel Ford Road. The county inspector does have an approved mitigation plan, however, they builders have yet to implement the plan. According to the company there should be people on site as early as January 11th. We are

still waiting to find out if there will be any more permitting needed from the county as far as the scope of what they are doing. Staff is following that closely.

9. City Administrator Report:

a. End of Year

Administrator Greenwood reported that Andy Smith and Maria Queen are wrapping up the calendar year financial requirements.

b. Park Update

Mr. Greenwood said that the large memorial stone has been delivered and the memorial plaza is coming along quickly. The bases are being poured and the bridge replacement is on schedule. Mr. Greenwood asked what name Council has decided on to be finalized in February. Mayor Brunson said that they have agreed on Gills Creek Memorial Park.

c. Vulture Issues

Mr. Greenwood said that there have been several reports of vulture activity in the Laureate. Administration has authorized through permitting for the neighborhood to shoot off what is called a bird banger. The mechanism shoots off a firework at night and in the morning to scare off the vultures. Dispatch and FAPD have been notified that the process has been permitted.

d. Recruiting and Bonuses

Mr. Greenwood said that Chief Robinson has brought up that FAPD is not getting enough applications for employment. Mr. Greenwood added that Public Works is also experiencing the same problem. A sign-on bonus has been discussed. If Council agrees then a proper plan will be brought in February 2023.

e. Holiday Lights

Mr. Greenwood said that our park should be opened by October 2023, and we will bring quotes for new Holiday Lighting in February.

f. Water Leaks

Mr. Greenwood reported that there have been several water leaks in Forest Acres. They have been reported to Columbia Water as they have been identified. He encouraged everyone to report to the City of Columbia through their app.

10. Finance Director Report: Monthly Financial Report

Assistant City Administrator/Finance Director Smith reported that our Annual Audit should be reported to Council in February. The key to the audit is that it is a clean opinion with nothing unusual. Mr. Smith did include in his monthly report a mid-year analysis of funds. We are in a normal cycle in revenues and expenditures. Mr. Greenwood added that we will soon be applying for reimbursements from SCDOT for the bridge replacement.

11. Police Chief's Report:

Chief Robinson reported the December 2023 crime and traffic statistics to Council.

There were no training classes in December 2023. However, they will resume in January 2023.

FAPD aids residents when they are locked out of their vehicles.

Traffic initiatives remain in place and are working out well.

There are three front porch roll calls scheduled for January.

A potential recruit is possible from the Law Enforcement Career Fair in Charleston, SC.
