# MINUTES OF THE FOREST ACRES CITY COUNTIL VIRTUAL ZOOM MEETING July 19, 2022

Mayor Frank Brunson, Mayor Pro-tem Tom Andrews, Council members John Barnes, Haskell Kibler, and David Black were present, along with City Administrator Shaun Greenwood, Police Chief Don Robinson, and City Attorney Will Dillard. Assistant City Administrator/Finance Director Andy Smith was absent.

### Mayor Frank Brunson called the meeting to order at 6:00 p.m.

#### 1. Invocation and Pledge of Allegiance

Council member John Barnes led the invocation and the Pledge of Allegiance.

## 2. Approval of Minutes

a. City Council Meeting held June 11, 2022

On a motion by Mr. Andrews seconded by Mr. Kibler, Council unanimously approved the minutes.

b. Special City Council Meeting June 28, 2022

On a motion by Mr. Black seconded by Mr. Kibler, Council unanimously approve the minutes as amended.

# 5. New Business:

a. Presentation of new FAPD Officers

Officer Joe Sankitts, Officer Brendan Browning, and Class 3 Advanced Officer Eric Sapp were all introduced by Chief Robinson as new hires for FAPD.

### b. Update on Zoning Ordinance Revisions

Kelly Cousino with White and Smith updated Council on the revisions that have been made and what to expect over the next few months. They are recommending consolidating the Zoning Ordinance and Land Development Regulations into a single document.

c. Discussion of a mutual aid agreement with the Cayce Police Department
On a motion by Mr. Barnes seconded by Mr. Andrews, Council unanimously approved the agreement.

#### d. Discussion of utility box wrapping project

Mr. Greenwood discussed with Council that the Beautification Foundation is heading this project to add some beautification to utility boxes in our city. There will have to be an application to the SCDOT for an encroachment permit. Council discussed the art that was submitted and asked Public Information Officer Lynnsey Baker to solicit art and/or still photography from sources within Forest Acres. On a motion by Mr. Andrews seconded by Mr. Barnes, Council unanimously authorized Mr. Greenwood to apply for the encroachment permit.

On a motion by Mr. Andrews seconded by Mr. Black, Council unanimously appointed Jessica Mayo.

#### 6. Old Business:

- a.   - On a motion by Mr. Andrews seconded by Mr. Barnes, Council unanimously approved the ordinance.

# 7. City Administrator Report:

a. Sign Ordinance

Mr. Greenwood reported that Code Enforcement has been driving around and notifying the City's businesses regarding Council asking Administration to begin enforcing our Sign Ordinance after being relaxed due to the pandemic. Businesses have been given until July 31, 2022, to remove any temporary signage.

b. FLP Park Update

We had a preconstruction meeting with our contractor and all the documents have been signed. Activity should begin at the end of August with hard construction beginning in early September. Mr. Greenwood added that we need to begin planning a ground-breaking if Council would like to have one.

c. End of Fiscal Year

The fiscal year has wrapped positively, and our annual audit process has begun.

# **8. Finance Director Report:** Monthly Financial Report

Mr. Greenwood said that since we are only nineteen days into the new fiscal year that there is no report at this time. Mr. Smith will have a report in August.

#### 9. Police Chief's Report:

Chief Robinson reported to Council July 2022's traffic and crime statistics.

FAPD's traffic initiative remains in effect.

A project to get crime, weather, traffic, etc. alerts out to our local businesses in in process.

#### 10. Community Forum:

Resident Stephen Oliver reported that "National Night-Out" will be held at Bethel United Methodist Church on August 2, 2022, at 6 pm.

#### 11. Council Items:

#### 12. Executive Session:

On a motion by Mr. Andrews seconded by Mr. Barnes, Council unanimously agreed to go into Executive Session.

On a motion by Mr. Andrews seconded by Mr. Kibbler, Council unanimously voted to go back into regular session.

On a motion by Mr. Barnes seconded by Mr. Kibbler, Council voted 4-1 to authorize the City Administrator to rescind the offer of a letter of intent as discussed in executive session. Mr. Andrews voted against the motion.
