MINUTES OF THE FOREST ACRES CITY COUNCIL July 25, 2023

Mayor Tom Andrews, Mayor Pro-tem David Black, Council members Haskell Kibler, Ryan Newton, and Stephen Oliver were present, along with City Administrator Shaun Greenwood, Assistant City Administrator/Finance Director Andy Smith, Police Chief Don Robinson, and City Attorney Will Dillard.

Mayor Tom Andrews called the meeting to order at 6:00 p.m.

1. Invocation and Pledge of Allegiance

Council member Haskell Kibler led the invocation and the Pledge of Allegiance.

2. Swearing in Mayor Thomas Andrews, Councilman Steven Oliver, and Councilman Ryan Newton Honorable Zack Atkinson swore in Mayor Thomas Andrews and Councilman Steven Oliver. Former Mayor Frank Brunson swore in Councilman Ryan Newton.

3. PUBLIC HEARINGS

The change would make the entire property in the creek access west overlay district. The purpose would be to facilitate construction of an improved marked public road from the recently rebuilt bridge through the parking lot to N. Trenholm Road. The overlay would not change the underlying zoning of the properties or add any new uses, instead it would be to preserve the status quo in terms of zoning issues across the board after the road is constructed. The Planning Commission recommended approval of the overlay district.

- a. Presentation and introduction of new FAPD Officers Chief Robinson introduced newly certified officer Treyvon Warren and promoted Officer Ryan Gause to the rank of Corporal.
- b. Presentation by Representative Heather Bauer and Tony Magwood from SCDOT Mr. Greenwood introduced Representative Heather Bauer and SC DOT Resident Maintenance Engineer Tony Magwood for a question and informational session with Forest Acres residents. Approximately twelve residents and one non-resident expressed concerns regarding potholes, neighborhood speed signs, and vegetation that causes site hindrances on city streets. Mr. Magwood reported on SCDOT's 10-year and \$5 million plan for state roads in South Carolina. Mayor Andrews asked what the most efficient way for the city and its residents would be to report problems or concerns'. Magwood reiterated to Council and the audience the importance of reporting concerns and problems on the DOT website. Council member Oliver asked about how SC DOT handles necessary repairs caused by utility companies. Mr. Greenwood expanded conversation on vegetation hindering views at intersection. Council member Black asked about speeding problems on the college avenues in Forest Acres. Following the question/discussion, Mr. Greenwood let the audience know that in the lobby were forms for residents to fill out with their questions and concerns and that all the information will be forwarded to Tony Magwood.

c. City Administrator Report:

a. GCMP Update

Mr. Greenwood reported that the contractor is waiting for materials to be delivered so that construction can commence. The park project remains on target for opening in October 2023.

b. Falcon Drive Speed Hump update

We received no bids from the public notice. We were able to obtain quote of \$37,000 through another avenue. We are looking into other ways of getting bids for installation. Construction will have to happen when school is not in session. At this time, it may be the Christmas holidays that the speed humps might be installed.

c. Richland Mall Park update

Mr. Greenwood said that he is arranging a meeting with the mall owners and the new Council members. The next step after that would be the publication of an RFQ to begin getting construction numbers.

d. Council Planning Session

A session is scheduled for August 7, 2023, from 9 am to 1 pm.

e. Zoning Ordinance update

We anticipate Module II to be ready from the consultants for Mr. Greenwood and Attorney Will Dillard to review and return comments. It will then go to Planning Commission. The new code will hopefully go live in Spring 2024.

f. Entryway Signage

We are working with Lexington Medical Center to have a sign that says Forest Acres installed at their current location that is being build on Forest Drive at the old Steak & Ale location. They are accommodating and have no problem with a sign if it does not interfere with their parking area or the right of way.

g. Code Enforcement position

The position is still open, and we will continue to work on filling it as soon as possible.

d. Finance Director Report: Monthly Financial Report

Assistant City Administrator/Finance Director Smith reported we are now in the beginning of a new fiscal year and are waiting for a few more payments to the city to close the 2022-2023 fiscal year. We do anticipate some additional accruals in revenue and accounts payables. We've expended 93% of our budget and have still have some ARPA funds to spend. We are not running any massive surpluses or deficits.

e. Police Chief's Report:

Chief Robinson reported the June 2023 crime and traffic statistics to Council.

FAPD has had more training in mental health, de-escalation, and leadership.

Recruitment of new officers continues under the difficult hiring market.
